"3. All the Heads of Department, all Heads of Offices, Drawing and all Disbursing Officers are requested to recover the employees contribution towards the Flag Day Fund @ Rs.100/- from Non-Gazetted employees and @ Rs.200/- from the Gazetted Officers every year from their salary of December payable in January and remit the same into the following savings account of the "Director, Sainik Welfare, TS Hyderabad" through "ONLINE PAYMENT".
