## **ORDER:**

- 2. Based on the recommendations of Pay Revision Commission, 2010 orders were issued in Government Order second read above, enhancing the rates of Training Incentive to certain categories of posts in the Training Institutions of the various departments.
- 3. In the Government order third read above, based on the recommendations of the Tenth Pay Revision Commission, orders were issued for implementing the Revised PayScales, 2015 to the State Government employees.
- 4. The Tenth PRC has recommended the following:
  - "The Commission is of the view that the existing instructions with regard to providing of training incentives to the faculty members/staff working in the training institutes are adequate and no further changes are required".
- 5. Government have decided to accept the recommendations of Tenth Pay RevisionCommission.Accordingly, the orders issued in the reference 2<sup>nd</sup> read above shall continue to remain in force.
