NEW PENSION SCHEME – Shifting of model of Interface from "Quasi Decentralized to Quasi Centralized" -Orders Issued.

## **ORDER:**

In the reference read above, the Director of Treasuries hassubmitted a proposal to change the model of upload from Quasi Decentralized to Quasi Centralized Model keeping in view of various constraints in the Quasi Decentralized Model in respect of the regular Government Servants, who were appointed under NPS and whose salary bills are drawn from PAOs/ DTOs/ STOs. Further, he has proposed to switch over from Quasi Decentralized to Quasi Centralized Model with effective from 01.04.2017 and all the uploads shall be done at DTA Office level with single Subscriber Contribution File (SCF) as per the guidelines issued by the NSDL, Mumbai.

- 2. The DTA has further informed that as per the present procedure, the CPS data for the respective month at central level is provided access to all the Treasury Officers by the DTA Office, then the Treasury Officer is required to verify the data, generate a text file, validate it and upload to the CRA and transfer of funds is done at the Treasury Officer's level. The existing procedure is cumbersome and is causing delays in remittances and reconciliation has become complex as large number of functionaries/ stages are involved. The monitoring of remittances has become difficult as 94 STOs and 30 DTOs has to be maintained.
- 3. Government after careful examination of the matter hereby issue ordersto make necessary Software arrangement with NSDL and DTA and also to adopt Server to Server integration with NSDL duly permitting to transfer the funds through online to the NSDL from PD Accounts 301, 302 and 303 under Head of Account: 8342-117-SH (04)-001,002 and 003 in respect of the regular Government Servants and Foreign Service employees. So that the funds can be transferred along with the date itself

for achieving 100% coverage without any delay at HOD level and Unit Officer's level.
